## The Linda Frierdich Group Moving Tips

1. **Clearances**-Please note– the height & length of the Truck before driving
2. **Drive Thru's**-Please **DO NOT** drive through Restaurants, Hotels, Banks, or Service Station drive-thru's, overhangs or canopies. There **IS NOT** enough height or width clearance.
3. **Slowing & Stopping**– The truck requires a little additional distance when slowing & stopping than the vehicle you are used to driving. A loaded truck can take 9 times as long in time and distance to stop as a passenger car. Please be sure your cargo is secure to avoid shifting.
4. **Parking & Backing Up**– Please set and use the mirrors. Please set the parking brake before getting out of the truck. Lock the truck & take the keys with you.
5. **Operating**-Drive a little slower and avoid passing. Please make sure to turn off radio, heat or A/C & all lights.

\*\*If you have a mishap, please call the Police right away. Insurance companies require a police report when filing a claim. Then, please call your insurance agent. Finally, call The Frierdich Group at 618.719.3134 and let us know what happened. If your insurance carrier denies the claim, you will be required to pay the deductible of Century 21 Advantage's Policy, plus a \$100 service charge.

## MOVING TRUCK PROCEDURES

- **You may reserve 1 day only. We can put you down for an additional tentative day and if it is not booked prior to that date, you may use the truck for additional time. THE TRUCK IS 1ST COME 1ST SERVE-No alternative trucks are available if the day you'd like is already booked!**
- **Date Scheduling can be arranged by calling Lindsey or Naureen at 618.281.7621 Monday– Friday 9 am-5 pm.**
- **Release form (next page), copy of Valid Driver's License, & Proof of Insurance must be turned into our office at least 1 business day prior to using the truck.**
- **Truck May Be Picked up anytime after 9 am and MUST BE returned the following morning by 8:30 am**
- **Instructions for returning the truck and keys will be given when you call to set your date. Do NOT lock door.**
- **The truck MUST be returned with a full tank of gas and in the same condition it was picked up in to 223 Southwood, Columbia .**
- **Please remember, you are responsible for ANY damage to the truck.**
