Please Note the Following:

- **Clearances:**

Please note the height and length of the truck before driving.

- **Drive Thru's:**

Please do NOT drive through restaurants, hotels, banks, or service station drive-thru's, overhangs, or canopies. There is NOT enough height or width clearance.

- **Slowing & Stopping:**

This truck requires additional distance when slowing and stopping than the vehicle you are used to driving. A loaded truck can take nine times as long in time and distance to stop as a passenger vehicle. Please be sure your cargo is secure to avoid shifting.

- **Parking & Backing Up:**

Please set and use the mirrors. Please set the parking brake before getting out of the truck. Lock the truck and take the keys with you when you exit the vehicle.

- **Operating:**

Drive a little slower, and avoid passing. When you are finished with the truck, please make sure to turn off the radio, heat or air conditioning, and all lights.

If you have a mishap, please call the police right away, because insurance companies require a police report when filing a claim.

Then, please call your insurance agent.

Finally, call The Linda Frierdich Group at 618.719.3134, and let us know what happened. If your insurance carrier denies the claim, you will be required to pay the deductible of Century 21 Advantage's policy, plus a \$100 service charge.

Truck must be returned by 8:30 am the following day.

Please Drive Carefully & Stay Safe!

Moving Truck Procedures:

- **You may reserve one day only.** We can put you down for an additional tentative day, and if the truck is not booked prior to that date, you may use the truck for additional time.
- **The truck is first come, first serve.** No alternative trucks are available if the day you'd like is already booked.
- **Date scheduling** can be arranged by calling Heather or Cindy at 618.2817621, Monday-Friday, 9 am-5 pm.
- **Release form** (other side), copy of valid driver's license, and proof of insurance **must be turned in to our office at least one business day prior** to using the truck.
- **The truck may be picked up any time after 9:00 am, and it must be returned the following morning by 8:30 am.**
- Instructions for returning the truck and keys will be given when you call to set your date. **Do NOT lock the door.**
- The truck must be returned with a **full tank of gas** and in the **same condition** as it was when picked up. Return to the same place you picked it up, 223 Southwoods Center Drive in Columbia.
- Please remember that **you are responsible for any damage** to the truck.
